Players will play only others in their section (i.e., a 1st grader will only play against others in grades K-3). **If there is not a minimum of 5 players in a division, that division will be cancelled and all monies shall be returned. Notification of any cancellation will be given as early as possible. The 9-12 division is the only one ever in jeopardy of cancellation.**

Prizes: Trophies will be awarded to the top three players in each section. Participation ribbons will be awarded to all players. **The champion from each division will be awarded entry to the Colorado State Chess Championship played Feb. 15th and 16th in Denver.**

Supervision: All children are required to have adult supervision. Parents are responsible for arranging the supervision of their children. Tournament directors and tournament volunteers are prescreened adults who will supervise the tournament area only. Parents will not be allowed in the playing area of the tournament room. Students are released to their adult supervisors between each round of play.
